Mayor Radeff says today, I am going to offer to have Elliot Palmer hopefully to be sworn in as our new full time police officer. I know him personally; he is a local Sheffield Lake resident and his father is the head at Mercy Hospital. He has been an officer in Lorain where I have been a prosecutor. I have high regard for him. He is an excellent officer, he is good on the stand, he himself wanted to be an attorney and he is definitely more than capable of taking that step if he wanted to. I have highly vetted him. He has had multiple commendations through Lorain, especially from the council people who have said he is very professional. Obviously, we have all seen there has been some public opinion on one individual incident, but I really wanna stress that not only is he highly qualified, I have absolute trust that he is

going to do great for Sheffield Lake. I would stress don't let public opinion keep us from hiring someone who is more than qualified for this position. Chief Kory says Officer Palmer grew up in Sheffield Lake, graduated from Brookside in 2016 and he has a bachelor's degree from Kent State University. He has been on Lorain police for 3.5 years and nominated twice for the lifesaving award, nominated for blue star for injuries sustained in the line of duty, etc. He is a very decorated officer and I think he would make a great addition. Officer Watkins states I was on the hiring committee when he first applied. Aside from giving a good interview, Lorain is a very tough place to police. I never had complaints of him talking to anybody inappropriately, he is a very conscientious young man. I've been doing this job for a long time and I wholeheartedly endorse him. *Motion by Gee/Second by Kovach to approve the hiring of Elliot Plamer for full-time police officer.
